



### **ALA GUIDELINES FOR LIFE MEMBERSHIP**

1. Life Membership may be awarded for significant contributions to the Australian Lacrosse Association (ALA) as per Clause 11.6 of the ALA Constitution.
2. This distinction shall be conferred only at the discretion of the ALA Board.
3. Nominations for Life Membership must be forwarded to the ALA Administration Director within the stipulated time frame.
4. Any current Member Association may nominate a candidate for Life Membership.
5. Nominations should include the Member Association's reasons for recommending the candidate for Life Membership.
6. No person shall be elected a Life Member of the ALA unless they have the majority of the votes from the ALA Board.
7. The candidate must have been a contributor to lacrosse in Australia through an ALA Member Association for at least 10 years.
8. In addition to the above, the candidate must satisfy the following criteria:
  - demonstrated long-term duration of services rendered, and / or
  - significant achievement at the highest level, and / or
  - a voluntary contribution to lacrosse which stands out above all others
9. Satisfaction of the criteria described above does not infer automatic granting of Life Membership. These criteria are for the guidance of the ALA Honours & Awards Committee and the ALA Executive Board when assessing nominated candidates.
10. The criteria for candidature, as described herein, may be adjusted in extreme circumstances, including but not limited to posthumous Life Membership, at the discretion of the ALA Committee.
11. A Life Member of the ALA is a fully financial Member of the ALA for life.
12. A Life Member of the ALA will be presented with a badge and a framed certificate to recognize and commemorate this person's significant contribution to the ALA.
13. This presentation will be made at a time considered appropriate by the ALA Board.
