ClassMarker was recently selected by the ALA as the national official's accreditation testing tool.

The ALA Director, Officiating will be responsible for managing the system, supported by the MNTC for the testing men's lacrosse officials, in accordance with this plan.

This plan sets out the methodology / structure for allocating system roles and responsibilities to be used in setting it up and managing ongoing use.
