

2022 Life Membership

In 2022, Lacrosse Australia (LA) awarded Life Membership to Ian Toy in recognition of his significant service to lacrosse in Australia and Western Australia. LA recognise and are grateful, for Ian's dedication and passion to develop and promote the sport of lacrosse at club, state and national levels as a player and administrator.

The award was presented to Ian at the Annual Kuljak Dinner held in WA on 17 August 2022, with family, friends and peers in attendance.

lan's achievements as a player on the field were impressive. After starting over 60 years ago at the Subiaco Lacrosse Club in 1959, lan represented WA at both Junior and Senior levels gaining numerous player awards and captaining his club South Perth to a Premiership in 1973 before working up to captaining the Australian team at the 1974 World Championship in Melbourne. Subsequently some years after he ceased playing (1986), in 2000 lan was named to the WALA Team of the Century. Ian was a skilled and tenacious defenseman and he carried that tenacity through into sports administration where he was as successful off the field as he had been on it. lan had a number of coaching roles, mainly at Subiaco across both Junior and Women's versions of lacrosse and he has held many administrative roles but his involvement in establishing the Wanneroo Club with Malcolm Stokes, his work with the Western Australian Lacrosse Foundation and his Presidency of the WALA are probably stand out roles. In addition to this lan's unparalleled knowledge in documenting lacrosse history particularly in WA where he is the author of 'A History of the Western Australian Lacrosse Association 1896 to 2010' have been recognised by Lacrosse Western Australia who nominated lan for a Lacrosse Australia Life Membership.

2022 Player Awards

Shelley Maher Trophy - Best and Fairest Women's Player Rebecca Lane (VIC)

The Shelley Maher Trophy is awarded to the best and fairest player Australia-wide in the most senior women's competition in each state's home and away qualifying round matches, based on votes awarded by match umpires. Rebecca had an outstanding season playing a total of 9 home and away games for Footscray Lacrosse Club's State League Women's team scoring 19 goals and 8 assists.



The trophy is named in honour of Shelley Maher and was instituted in 2012 by the Australian Lacrosse Association. As the last President of Women's Lacrosse Australia (2001-2009) Shelley committed to excellence in all areas of administration. In her home State of Victoria. Shelley was President of Women's Lacrosse Victoria (1998-2001), and was elected a Life Member in 2001. In 2009 Shelley was elected a Life Member of Women's Lacrosse Australia. She was active as a player with Williamstown Women's Lacrosse Club and represented Victoria in senior competition (2002, 2005). Shelley was an Australia Lacrosse Association Director (2007-2010), and the Women's Director on the Federation of International Lacrosse (2008-2017). In 2017 Shelly was awarded the World Lacrosse Lifetime Achiever Award.

O.C. Isaachsen Trophy - Best and Fairest Men's Player Garrette Briggs (SA)

The Isaachsen Trophy is awarded to the best and fairest player Australia-wide in the most senior men's competition in each state's home and away qualifying round matches, based on votes awarded by match referees.

Garrette played a total of 14 home and away games for North Eagles Lacrosse Club's State League Men's team scoring 12 goals and 11 assists.



This award was donated by Cedric Isaachsen to the Australian Lacrosse Council (ALC) in 1963. Cedric Isaachsen was a remarkable man who had a distinguished military career, rising to the rank of Lieutenant Colonel and earning the honour of Companion of the Distinguished Service Order (DSO), followed by a distinguished legal career. Mr Isaachsen was President of ALC 1962-65, then Vice-President for 14 years until 1979. He was elected as a Fellow of the ALC in 1994. He lived in South Australia and died in 2009, aged 97 years.

President/Chair Report – Adrian Burns

On behalf of the Board of Lacrosse Australia I am pleased to present the Annual Report for 2022.

2022 has been an interesting year. As we have moved out of the impacts of the Covid-19 pandemic bringing Lacrosse in Australia back to a stable and sustainable position has been extremely challenging. In the early parts of the year the effects of the pandemic were still a significant concern and Lacrosse Australia has continued to work closely with the Member Associations to manage and mitigate the impacts the pandemic had on the numbers of participants playing our game and the challenge of continuing competitions in the face of a significant reduction in volunteers administrating and coaching in our leagues and growth programmes.

During 2022 our Member Associations have continued to deliver lacrosse to their members. In NSW for the first time in over a decade, Junior lacrosse was played with over 50 new young lacrosse players playing two five-week programs in what was an exciting development, whilst at Senior level an embryonic domestic competition led to NSW sending a Senior Men's team to the Nationals for the first time in three years. In Queensland, the Mountain Live Programme was a huge success driven by an enthusiastic team led by Ray Trevaskis with support from LA's growth programme and coaches from the other States.

Domestic competitions went ahead in all States and Quick Stix numbers continued to grow to record levels, except in South Australia where the availability of coaches had an impact and in Tasmania where it has been difficult to gain traction on implementing programmes since Covid-19 started. Although our overall player numbers dropped slightly to 4350, as we moved out of the Covid-19 era our participant numbers have remained stable at around 45,000 (44,944)

Two of the more exciting initiatives undertaken by the LA Growth team this year, were the subsidised or funded programmes organise in Townsville, North Queensland and Port Hedland in WA, where although we haven't been able to establish programmes, we brought some insight of lacrosse to the local communities. Overall, these participation and growth numbers

show that although the future for lacrosse in Australia will be challenging, we can expect to get our growth and participation back on track.

The success of returning domestic competition was an enormous effort and a testament to the passion and drive of the lacrosse community in our Member Associations and clubs.

At a National level, although late Covid-19 based travel restrictions forced the delay and then ultimate cancellation of the 2022 Box Lacrosse Nationals, all the other National competitions continued with the Senior National Championship in June, a rescheduled U18 National Championship held in July and the U15 National Tournament held in September October. Details on the winners and results can be found in the Competition Section of this Annual Report.

As Covid-19 travel restrictions ended early in 2022 across most of the world, World Lacrosse followed through with the planned 2022 Women's World Championship and The World Games events. The Australia teams were able to attend key events including the 2022 Women's World Championship in June in Towson, Maryland, USA and the U21 Men's World Championship in August in Limerick, Ireland. Additionally, The World Games took place in Birmingham, Alabama, USA straight after the Women's World Championship from July 12 - 16, 2022.

Our National Teams had mixed success at the World events where the Women's Team secured a second consecutive fourth place at the Women's World Championship and were unlucky to miss out on Bronze Medal after taking England to the line before unluckily conceding the defining goal in overtime.

At this point Lacrosse Australia would like to recognise the Sofarnos Foundation, established to recognise the late Sue Sofarnos. The SSF assisted the 2022 Australian Women's Team as the first team to leave the shores of Australia for International Competition being fully funded. This was a great bonus for the women taking part and helped in the team's success.



The Australian Women's Sixes Team then joined the Australian Men's Sixes Team at the 2022 World Games in a Sixes competition where the Women playing against fresh sixes teams from other countries secured the Bronze Medal they deserved in Towson and the Men achieved an admirable sixth place finish.

In Limerick Ireland, the long awaited and Covid-19 delayed U21 Men's World Championship took place and Australia secured a great fourth place finish.

One of the highlights of 2022 for Lacrosse Australia was the success in being granted the hosting rights to the inaugural 2023 ASPAC Lacrosse Sixes Tournament which will take place in November 2023 on the Gold Coast Queensland. Congratulations are in order to SDOC Steve Campbell who managed a superb bid process to secure this award. This was a just recognition after Lacrosse Australia disappointingly failed in a joint bid with World Lacrosse, the Asia Pacific Lacrosse Union and Lacrosse Victoria to secure a 2026 Commonwealth Games competition.

On the local front we also had some positive and some sad memories. In Western Australia Ian Toy was recognised for the fabulous contribution he has made to game of Iacrosse in WA and across Australia and was announced as the most recent Life Member of Lacrosse Australia. Ian's achievements as a player on the field were impressive and after captaining the Australian team at the 1974 World Championship in Melbourne, in 2000 Ian was named to the WALA Team of the Century.

On a sadder note, Lacrosse Australia wishes to recognise the passing of Ray Trevaskis. Although Ray passed away after a prolonged illness early January 2023, it would be remiss to not recognise his contribution in this report. Ray was a tireless and passionate advocate for the growth of lacrosse in Australia. A larger-than-life character not afraid to share his opinions, Ray was someone you would never forget meeting (or speaking with on the phone). Ray's passion flowed over to every conversation and his encyclopaedic knowledge of his version for lacrosse in Australia was always fun to engage with.

Although Ray started his lacrosse career in the colder climes of Victoria he latterly graduated to Queensland where he became known worldwide as the driving force behind initially the annual Paradise Tournament and more recently was reinvigorating the growth of Lacrosse Queensland with his unbounded energy as he drove the Mountain Live and other junior lacrosse growth programmes. Ray's passing is a huge loss to lacrosse in Australia and especially in Queensland and it will be important that Lacrosse Australia supports the continuation of his legacy driving Junior Lacrosse in the region so that we do not lose the impetus he has given the sport.

Strategically 2022 has been a challenging year with a significant turnover in Directors and staff for such a small organisation and the increasing demands of the workload on a volunteer and operational Board are something that Lacrosse Australia needs to focus on moving forward.

Although Lacrosse Australia are generally on track with most of our key result areas moving forward into 2023, we will need to see a strong focus on reinvigorating our Strategic Plan which has now lapsed whilst we focus on addressing the key performance indicators agreed with Sport Australia.

During 2022 Lacrosse Australia completed strategic works on a review of our High Performance program and we anticipate adopting this report in mid-2023, whilst work was also undertaken on a revision to the Events Calendar in an attempt to address the increasing demand on time and resources our smaller sport needs to undertake generated by the multitude of National and International competitions we will take part in. The conclusions of this LEC report will also be formalised and presented to Member Associations in mid-2023.

One of the big changes to occur for Lacrosse Australia in 2022 was the introduction of our first National Integrity Manager. Appointed in July 2022 with ASC funding we share our manager with two other sports Archery and Modern Pentathlon. Working within the National Integrity Framework and alongside Sports Integrity Australia our Integrity Manager has had a varied and interesting induction as Lacrosse Australia has experienced a shift in our integrity policies and approach to match federally supported standards. Although challenging at times we are confident our relationship with SIA and the NIF will only continue to grow and improve to better our sport nationally and internationally.

As my time as Chair comes to an end, I would like to offer my thanks to the Board of Directors I have worked with throughout 2022, they have worked tirelessly to do their best under trying and challenging circumstances to achieve the best possible overall result.



2022 saw resignations from Tania Orr and Caroline McLuckie for personal reasons. The return from maternity leave of Abbie Burgess and Carly Post and the decision to not stand for re-election by Mark Polden Director of Officiating. On the opposite side of that coin, we have been joined by Director's Karen Meredith – Finance and Bill Barton both of whom are casual vacancies and will be standing for election at the 2023 AGM.

After the completion of his previous two year term which had been extended because of Covid-19, Lacrosse Australia re-appointed Paul Mollison to the Director High Performance role for a further two years to enable the continuation of our High Performance program through a busy and challenging period whilst also taking on the responsibility to implement the High Performance Review agreed outcomes.

At this juncture I would like to take this opportunity to thank Mark Polden for his service to Lacrosse Australia and officiating generally. Mark has been a valuable member of our Board and has made the decision to not stand for re-election. Mark has provided LA with a wealth of experience and knowledge which has contributed to shape Lacrosse Australia, our officiating program and now World Lacrosse's approach to officiating.

During 2022 we also said goodbye, for now, to Caroline McLuckie our Director of Finance, leaving for personal reasons, Caroline was a foundation to our governance, administration and finance management and will be sorely missed. I would personally like to thank Caroline for her support and engagement over the years with Lacrosse Australia and I am sure we will see Caroline again in the lacrosse community either officiating sixes, managing teams or involved in NSW Lacrosse.

Finally, I would like to thank all the players, coaches, officials, volunteers, who make up our Lacrosse community and continue to work tirelessly to allow us to enjoy "the Creator's Game."



Finance, Governance & Administration Report – Karen Meredith

The 2022 Annual Report provides a complete insight of reporting for the calendar year.

As with previous years, guided by ASC, the LA Board set out several key performance indicators. A summary of these can be found in Directors Report and in the Audited Financial Statement for the period and listed in the KPIs. These KPIs drive the budget of the organisation, as well as feedback from our Member Associations.

In our first year of recovery from Covid-19 our Growth & Development (QuickStix) revenue increased from the previous two Covid-19 years, but not yet returned pre-covid years.

Also, in the first year of recovery from Covid-19, membership numbers and revenue are on the increase from 2021 but also not yet returned to precovid years. LA staff positions increased from one to two from the previous year, with an emphasis on the area of Growth & Development. The Social Lax project did not achieve as expected and was discontinued in December 2022, with the balance of the funding to be returned to ASC.

Areas of spending increases (from 2021 to 2022) include, QuickStix Coaches, U21 Men's Team Support and Salary & On-Costs with the replacement of a second employee.

Areas of income increases (from 2021 to 2022) include, QuickStix, Membership Fees and additional Grants from ASC (Social Lax), World Lacrosse (Coach Education, Equipment) and Sport & Recreation Victoria (infrastructure for 2022 Senior National Championship). 2023 will aim to return to pre-covid operations while maintaining a conservative budget.

Together with LA being awarded the APLU ASPAC Lacrosse Sixes Tournament on the Gold Coast Queensland in November 2023, a significant grant was applied for and approved. We look forward to welcoming international teams and showcasing our Australian Men's and Women's Sixes teams at a world class event and venue (Cbus Stadium).

Competition Report – Steve Campbell

In 2022 the national event calendar continued to be interrupted by covid travel restrictions. Due to these restrictions' events planned to be held in quarter 1 of 2022 were either cancelled (Southern Crosse, Men's Box) or postponed (U18).

As travel resections eased, national events were allowed to be held later in the year, The first national event to be held, since the start of the covid pandemic, was the 2022 LA Senior National Championship in June, followed by the 2022 LA U18 National Championship held in July (postponed from April) and then the 2022 LA U15 National Tournament held in the Sep/Oct school holidays.

2022 National Event Results

Senior Nationals

The 2022 LA Senior National Championship was held at Footscray Lacrosse Club in Victoria with a total of 11 teams competing, including QLD entering standalone men's and women's teams (first time in 30 years) and NSW entering a standalone men's team:

Women's event teams: SA, VIC, WA, NZ, QLD

Men's event teams : SA, VIC, WA, QLD, NSW, U21 Australian Team The VIC men's and women 's teams were crowned champions after defeating WA men's and women's teams in the championship finals.

Thank you to Footscray Lacrosse Club, their committee and volunteers who supported the delivery of the 2022 Senior Nationals.

U18 Nationals

The 2022 LA U18 Boys & Girls National Championship were postponed from April to the July school holidays. The event was held in SA at Glenelg Lacrosse Club. In total 8 teams were entered into the event (4 teams in each boy's and girl's event) being: SA, VIC, WA and NZ.

SA boy's team claimed the boy's championship over WA while the VIC girl's team claimed the girl's championship after defeating SA.

Thank you to Glenelg Lacrosse Club, their committee and volunteers who supported the delivery of the 2022 LA U18 Boys & Girls National Championship.

U15 Tournament

The 2022 LA U15 Boys & Girls Tournament was at HBF Arena in Perth WA and hosted by Wembley Lacrosse Club. A total of 17 teams competed in the event:

Boy's Event:

SA: Phantoms, Stingrays VIC: Northern Warriors, Southern Crosse, Western Metro WA: Braves, Northern Thunder

Girl's Event: SA: Comets, Lightning, Storm VIC: Fire, Ice WA: Flames, Stars, LA: LA President's NZ: Auckland, Waikato

For the Boys event Braves were the tournament winner after defeating Northern Thunder in the final while Comets were the girls tournament winner after defeating Waikato.

High Performance Report – Paul Mollison

OVERVIEW

After a one-year delay due to Covid-19, 2022 was highlighted with the July 2022 World Lacrosse Women's Championship in Towson Maryland USA. The Australian Women's Team completed a courageous fourth place, after an intense battle for Bronze against England. Congratulations to Head Coach Trish Adams and team for their results of each game throughout the event.

Following the Towson event, the Australian Women's Sixes Team met the Australian Men's Sixes Team in Birmingham Alabama USA to compete at the July 2023 IWGA The World Games.

The World Lacrosse Sixes discipline aimed for competition at the Olympics, was well received by the large crowds. Our Men's Team finished in sixth place, while our Women's Team achieved a Bronze Medal victory over Great Britain.

After a two-year delay due to Covid-19, 2022 was also highlighted with the August 2022 World Lacrosse U21 Men's Championship in Limerick Ireland. The U21 Australian Men's Team completed a courageous fourth place, after an intense battle for Bronze against the Haudenosaunee. Congratulations to Head Coach Gavin Leavy and team for their results of each game throughout the event.

WORLD LACROSSE

One world event will take place in 2023 with the Australian Men's Teams competing at the, June 2023 World Lacrosse Men's Championship in San Diego California USA.

ASIA PACIFIC LACROSSE UNION APLU

December 2022 saw Australia awarded the hosting of the inaugural 2023 ASPAC Lacrosse Sixes Tournament. The event will take place in November 2023 at Cbus Stadium on the Gold Coast Queensland. Both the Australian Men's and Women's Sixes Teams will compete at the event.

HIGH PERFORMANCE ADMINISTRATION

Player Contracts continue to be issued on an annual basis, as well as Team Staff Contracts with position appointments.

HP Athletes and Support Staff undertake SIA on-line Education courses annually.

Officiating – Mark Polden

2022 had many officiating challenges as we continue the climb out of the Covid-19 pandemic hole. Unfortunately, like every other aspect of this sport the recovery of the number of Officials to pre-pandemic status has not yet occurred.

The Men's National Technical Committee (MNTC) and the Women's National Technical Committee (WNTC) continue to meet regularly to provide coordination, education, and leadership for the Officials in Australia.

In 2022 the Women's National Technical Committee (WNTC) was expanded to include Caroline McLuckie in the role of LA Sixes Chief Official. Similarly, the Men's National Technical Committees (MNTC) was joined by Steve Green in the role of LA Box Lacrosse Chief Referee.

At all the National Championship events and Tournaments in 2022, we encountered great difficulty in attracting Officials (umpires and referees) to participate in the LA events. The 2022 LA U18 Boys & Girls National Championship in Adelaide suffered from the majority of the WNTC members being involved in the 2022 World Lacrosse Women's Championship in Towson, Maryland USA.

Many thanks the Stephanie Allen and John Sedgeway for providing coaching, support, and coordination for the Women's Officials.

The 2022 LA Senior National Championship held at Footscray LC in Victoria was also affected by the unavailability of suitably accredited Officials for the men's and women's events.

The 2022 LA U15 Boys & Girls National Tournament in Joondalup WA had many new officials at their first national event, yet quite a few could not attend all of the tournament due to work and educational commitments.

All events were officiated well and were successful.

In particular due to the efforts of all the officials, the officials' coaches, and the Referees in Chief and Umpires in Charge who coordinate and volunteer their services to facilitate the Lacrosse Australia events.

David Campbell has not continued in the position of Lacrosse Australia Referee in Chief (LARIC) due to personal reasons, as he was unable to give the position the time and effort it requires. LA thanks David for the work and passion he has put into the position and wish him well for the future. In November 2022, Ian McRae was appointed to the LA RIC position.

It is with great regret that for personal reasons I will not be seeking reelection to the Board for a last eligible term as Director Officiating on the Lacrosse Australia Board.

With the changing nature of the sport, the operational demands made on volunteer Board members and our appointed staff, maintaining the enthusiasm to continue in the face of the challenges we have experienced has been hard.

Although Steve Campbell has recently resigned as SDOC, we were blessed to have an employee with the ability to streamline our operations.

Steve's efficiency and work ethic allowed board members to believe that they could be more strategic than operational, and I would like to take this opportunity to congratulate Steve Campbell on his achievements and efforts to make Lacrosse Australia an efficient and functional organisation. I personally want to wish him all the best for his future endeavours.

Thank you to the LA Directors and Member Associations for my time here and all the very best with the 2023 season and beyond. I will still be around to assist where needed.

Lacrosse Australia (LA) has continued working towards lifting its marketing and social media presence across the board with major projects this year including the announcement of Australian Teams for world events with exciting and eye-catching graphics, covering world events in conjunction with the Australian Lacrosse Network (ALN) including;



While not every fixture turned out the way they wanted, the NSW men's team showed a lot of determination & was able to compete in 6 games in five days after a 3 year break from national competition. The victory against Queensland was the first win for NSW in multiple decades at the Senior Nationals and is hopefully the first of many to come!

Development

For the first time in over a decade, lacrosse was available to juniors in NSW! Held in Maroubra's Snape Park between May & Nov of 2022, over 50 of Sydney's newest lacrosse players gathered for two five-week programs that featured fundamentals, game play, prizes, & much more!



The financial statements cover Australian Lacrosse Association Ltd as an individual entity, incorporated and domiciled in Australia. Australian Lacrosse Association Ltd is a company limited by guarantee.

Note 1 – Statement of Significant Accounting Policies

Financial Reporting Framework

The directors have prepared the financial statements on the basis that the Company is a nonreporting entity because there are no users dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the *Corporations Act 2001*. The Company is a not-forprofit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the *Corporations Act 2001* and the significant accounting policies disclosed below, which the directors have determined are appropriate to meet the needs of members. Such accounting policies are consistent with those of previous periods unless stated otherwise.

The financial statements, except for the cash flow information, have been prepared on an accrual basis and are based on historical costs unless otherwise stated in the notes. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise. The amounts presented in the financial statements have been rounded to the nearest dollar.

Functional and Presentation Currency

These financial statements are presented in Australian dollars, which is the Company's functional currency.

Use of Estimates and Judgement

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

Accounting Policies

a) Revenue

Revenue is recognised when the Company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Revenue is recognised net of the amounts of goods and services tax (GST) payable to the Australian Taxation Office.

The Company's revenue includes grants received from the Australian Sports Commission and membership fees.

Grants received on the condition that specified services are delivered, or conditions are fulfilled, are considered reciprocal. Such grants are initially recognised as a liability and revenue is recognised as services are performed or conditions fulfilled. Revenue from non-reciprocal grants is recognised when received.

Sponsorships are recognised as a liability and converted to revenue when the equivalent services are performed or conditions fulfilled.

Membership fees are recognised upon the delivery of the service to the members.

Donations and sponsorships are recognised when received.

Interest revenue is recognised on an effective rate basis taking into account the interest rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST).

b) Inventories on Hand

Inventories are measured at the lower of cost and current replacement cost.

c) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within trade and other payables in current liabilities on the statement of financial position

d) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members and any outstanding grant and other receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

e) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment

Plant and equipment are measured on the cost basis. The carrying amount of plant and equipment is reviewed annually by Directors to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the asset's employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

Depreciation

The depreciable amount of all non-current assets is depreciated on a straight line basis over their estimated useful lives to the company commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of assets are:

<u>Class of asset</u> Plant and equipment

Depreciation rate 10-100%

f) Payables

Accounts payable are recognised when the Company becomes obliged to make future payments resulting from the purchase of goods and services.

g) Income Tax

The Company has received an endorsement from the ATO confirming that it is exempt from income tax.

h) Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the balance sheet.

Cash Flows are presented in the cash flow statement on a gross basis, except for the GST components of investing and financing activities, which are disclosed as operating cash flows.

i) Employee Entitlements

Short-term employee benefits

Provision is made for the Company's obligation for short-term employee benefits. Shortterm employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and annual leave. Shortterm employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The Company's obligations for short-term employee benefits such as wages, salaries and annual leave are recognised as part of accounts payable and annual leave provision in the statement of financial position.

Contributions are made by the Company to an employee superannuation fund and are charged as expenses when incurred.

j) Leases

At inception of a contract, the Company assesses if the contract contains or is a lease. If there is a lease present, a right-of-use asset and a corresponding lease liability is recognised by the Company where the Company is a lessee.

However all contracts that are classified as short-term leases (lease with remaining lease term of 12 months or less) and leases of low value assets are recognised as an operating expense on a straight-line basis over the term of the lease.

k) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation of the current financial year.

I) Economic Dependence

The Company is dependent on the Australian Sports Commission for a substantial part of its revenue used to operate the business. At the date of this report the Board of Directors has no reason to believe the Commission will not continue to support the Company.

m) New standards and interpretations not yet adopted

During the year ended 31 December 2022, the Company has reviewed all of the new and revised Standards and Interpretations issued by the AASB that are relevant to its operations and effective for the current annual reporting period.

It has been determined by the Company that there is no impact, material or otherwise, of the new and revised Standards and Interpretations on its business and, therefore, no change is necessary to Company accounting policies.

The Company has not yet determined the impact on its financial report of new standards issued but not yet effective.
