# **PRESIDENT – Fiona Clark**

The mission of the ALA is "to provide leadership through the delivery of quality sports services and programs which ensure increasing participation for all levels of lacrosse (players, coaches, officials, administrators), and delivers international success." If the provision of opportunities for all to succeed in lacrosse in Australia is to be realized, the ALA must continue to be focussed on strengthening the foundations of our sport, and driving the implementation of a development program which will see an increase in the currently stagnant numbers playing lacrosse throughout the country. The ALA's Member Associations, New South Wales, Queensland, South Australia, Tasmania, Victoria and Western Australia, represent these foundations. The ALA Strategic Plan (2010-2013) seeks to reassert this focus, and deliver new and improved services to members.

The ongoing support of the Australian Sports Commission (ASC) has been integral to lacrosse in this country, and the ALA remains indebted to them for their funding (\$50,000 Sport Development Grant), and recognition. The ability to have on-going dialogue with the ALA Sports Consultant, Bob Kershaw, has been invaluable to the Board. These past twelve months the ASC has been instrumental in contributing to some of the ALA's strategic and operational functions, including facilitating a Directors' Training Day in March, the delivery of a Financial Literacy session in May, a presentation at the Presidents' Forum, and considerable advice with proposed Constitutional amendments. With the continued support of the ASC the ALA hopes to achieve further success in developing lacrosse with new programs, particularly at the junior level, which will reach the broader population.

The ALA Operational Plan forms the basis of ASC's review of assistance to our sport, and includes agreed key outcomes against which the Commission provides funding. These annual reviews by the ASC are undertaken to assess NSO's Operational Plans to justify the level of assistance from the ASC.

The actions and outcomes of the ALA's first year as a non-transitional Board in 2009 allowed the Board to continue to move forward in 2010; the increased capacity to change from a predominantly operational Board to a more strategic Board in 2011 will see the planned establishment of sub committees and non Directorship Chairs soon realized.

The success of the 2010 Men's Australian Team, in bringing home the bronze medals from the FIL World Championship, was a highlight of this calendar year. The twenty-three players and their support staff, led by renowned Head Coach, John Denic, are to be commended on their success in Manchester. There is no doubt however that the global lacrosse environment has changed and Australia's players now share the world stage with rapidly improving countries such as Japan and Germany. In order to overcome these challenges the ALA will need to embark on a rigorous and visionary culture and program shift in the immediate future to ensure that in 2014 in Denver Australia remains in medal contention. The ALA needs to ensure its programs are designed to get results and to unearth future champions. In order to do this significant resources are required which need to be wisely invested, and there need to be new initiatives that require innovation with rapid progression. The ALA pays tribute to the England Lacrosse Association for the undisputed success of this event.

It was a privilege to represent Australia as their delegate at the three days of meetings in the 2<sup>nd</sup> General Assembly of the Federation of International Lacrosse (FIL) which was held in conjunction with this Men's World Championship, and for Gary Brown to be in attendance also as Australia's observer. The Federation is acknowledged for the work they continue to do particularly in the field of development, which this year saw its membership reach 25 Full Members and 13 Associate Members.

I also represented Australia at the Asia Pacific Lacrosse Union (APLU) meetings. As the most developed nation in this region it is essential that Australia take more of a leading role in the Union, and that we continue to facilitate and provide opportunities for the development of lacrosse with our nearest neighbours, New Zealand. It is exciting that in July 2011 the New Zealand Lacrosse Association shall host the bi-annual ASPAC games in Auckland, which will see Australia participate in both the men's and women's competition for the first time.

The ALA recognizes that board composition, structure, and behaviour change over time as a result of various factors, and in 2010 this included the resignation of two Directors, Anne Kingston and David Fox. At the end of the Casual Vacancy, which resulted following Alan Frederick's resignation in early 2009, Bob Carter was appointed as the Manager for High Performance and the Men's Program, and Paul Mollison was appointed Women's High Performance Manager.

The lack of financial responsibility created uncertainty in the ALA's activities, which saw the association focus on a more proactive and outcome approach to its financial operations in 2010; a Bookkeeper was appointed for a three month trial period. Following on from the successful appointment of Gail Sedgeway to this position, which saw the ALA ultimately successful in achieving its set financial timeline targets, a 12-month contract was signed, which will see Gail continue in this role.

The appointment of MGI Perth as the ALA's Auditors in 2010 proved critical to the ALA's financial operations, and the calling of a Special General Meeting in March to change the financial year from 31 December to 30 June was a major factor in the Association being able to meet its legal and compliance requirements. With thanks to the committed efforts of Vivienne Parker-White, Gail Sedgeway and MGI Perth, particularly Amar Nathwani, the ALA has come through an extremely difficult and demanding period on a sound financial footing.

The ALA Board will continue to evaluate its operations, and in 2011 intends to establish an Audit Committee for this purpose.

National Championships have been conducted in NSW, WA, SA and Victoria this year, which has provided the opportunity to showcase our sport in four out of six of the ALA member states.

A successful Presidents' Forum was conducted in October, which followed on from the success of the inaugural Forum in 2009. It is acknowledged that an opportunity such as this engenders openness and accountability, with satisfaction and co-operation of Member Associations being essential to the ALA's operations.

The Board has focussed on governance and management through this financial year, and this work will continue in the coming months. The volume of work remains one of the greatest challenges for lacrosse, as it does with other small sports, administered by a volunteer workforce. There is a high level of public scrutiny of governance processes and performance, which are undoubtedly a deterrent in attracting volunteers to the sport, particularly at the National level.

I commend the Board on their commitment to the ALA, the sport of lacrosse and the governance of the sport. The Directors bring a broad set of skills to the association which is very necessary as we continue to develop this new organization; They are a very experienced group of people, who are well aware of the changes and needs for lacrosse to grow in Australia. In their roles the Directors constantly achieve so much with minimal resources, and this is possible through many hours devoted to the sport. I would like to thank them all for their contribution, and in particular acknowledge the support of the Administration Director, Vivienne Parker-White, for her tireless efforts.

I would also like to thank the Boards and Committees of the ALA's Member Associations. It is their enthusiasm and commitment that enables the sport to continue at the State level.

The ALA shall continue to work on building an efficient governing body for lacrosse in this country, and in all its activities endeavours to continue to provide equal opportunities for men and women, and maximize enjoyment for both participants and spectators.

Looking to the future it is clear that the ALA, and Australian lacrosse as a whole, continues to find itself at a challenging but exciting period in its history. The past few years have been a time of profound change, which has seen those who are truly committed to a joint National Governing Body survive and move forwards. As I complete my first two years as President/Chairperson know that I have been pleased to serve the sport, and I wish the incoming Board much success in the coming year.

# **COMPETITION** – Jan Jackson

2010 saw ALA take a focus on improving its profile in relation to national events.

It was decided that Australian teams, Senior Championship winners and Senior Championship Australian All Star teams would be presented with ALA gold medallions and Senior Championship officials would be presented with ALA silver medallions.

Under 21, Under 19, Under 17 and Under 15 winners would be presented with gold medallions and officials at these events would be presented with silver medallions. A different silver medallion would be presented as Most Valuable Player awards at all events.

A review of men's and women's events documents was conducted and the ALA Championship and Tournament By-laws were published in June 2010 which includes all ALA events. This document is available on the ALA website together with other related policy documents.

A trial of selection procedures for a women's Australian All Star team was conducted at Under 17, Under 21 and Senior Championships and will be reviewed at the conclusion of the Senior Championship.

The **5<sup>th</sup> Southern Crosse Tournament** was hosted by Lacrosse Victoria 2-4 January at Footscray Hockey Centre (artificial turf) with participating teams, Japan Kanto University, USA Combined Colleges and Under 19 Australian Squad. FIL rules and FIL trial rules were used during this event. Winners were the USA Combined Colleges team. A buffet dinner was enjoyed by participants at the conclusion of the tournament.

The **Under 17 Championship** was hosted by New South Wales Lacrosse 1-6 April at the Sydney Academy of Sport and Recreation, Narrabeen (grass fields). Participating teams were South Australia, Victoria, Western Australia and New Zealand Under 19.

Victoria won the Camille Hobbs Perpetual Cup, Championship Medallions, Janet Jackson Tournament Trophy, Jeannie Matthews Cup (SA v Vic) and Mellis Cup (Vic v WA). South Australia won the Rose Gaunt Trophy (SA v WA). Most Valuable Player medallions were presented after every game and all participants received a Participation Certificate.

# **COMPETITION – GARY BROWN**

The 2010 lacrosse year has been a significant one that has seen the operation of the board transfer from a portfolio base to a collective format. This shift in broad decision making has ensured a cross section of input into guiding the direction the board has taken. This has also enabled portfolio day to day operation to continue and assisted Directors in addressing the many minor issues that arise in operational matters.

In competition, the linking of national events on a co-gender format has been viewed by the wider lacrosse community as very positive. Operationally this has added to events and has been a step forward in raising the profile of national events. It is always a difficult task lining up events on the calendar but as a board, the ALA has endeavoured to work closer with member associations in determining these events.

Member Association communication and relationships continues to be an area requiring development if the ALA is to be a more responsive and dynamic national board.

From a men's perspective, the following report is directly linked to the operational plan. In summary, the following comments on the men's program are provided:

### State Event organisation

The running of a Lacrosse Tournament/Championship is a very big task. Each state has taken on this responsibility with relish ensuring all 2010 events achieved a high level of operation. Working with event coordinators and support is one of the positive outcomes from serving on the board. In all major Lacrosse states the passion for our sport in clear to see. These people must be looked after, with everyone continuing to work together in the future to grow lacrosse. Our lack of growth continues to be a key factor in national and state planning.

### Men's Senior World Championships 15 to 24 July Manchester England

I attended the Men's World Championships in Manchester England including the FIL General Assembly prior to the Championship commencing. I was one of two ALA delegates at the meetings and supported ALA Chair Fiona Clark in putting forward Australia's responses to various FIL agenda items.

Australia's performance on the international stage was a credit to players, coaches and everyone associated with the program. Competing against professional teams was always going to be a huge task. Australia should be very proud of bringing home the bronze medal. Lacrosse internally in Europe, South America, Canada and the USA is experiencing significant growth. This along with the large amount of money the English put into their team shows the true achievement of the Australian team.

### Trophy Agreement ALA with the Lacrosse Foundation

Work is ongoing towards establishing an agreement between ALA and the Australian Lacrosse Foundation for the use of trophies for men's competitions. This link with trophies that carry great history supports men's lacrosse and remains an area requiring consensus.

### Events 2010

### Senior National Championship

This event was at risk with the withdrawal of WA, however, after much discussion and support for the ALA board and Lacrosse Victoria, the event went ahead with the inclusion of a President's team and the participation of the 2011 Australian Indoor Squad. Congratulations to Victoria who defeated South Australia 13-3 to win the Senior National Men's Championship in Victoria.

### Under 17 and 19 Championships Perth July

Congratulations to Western Australia and Victoria for winning the U17 and U19 Championships respectively in Western Australia. In the U17's, Western Australia had a resounding victory, defeating Victoria 21-8. While the U19 result was a victory to Victoria by the narrowest of margins, 11-10.

### U15 National Tournament

Congratulations to Southern Braves WA who defeated Northern Thunder WA 17-3 to win the U15 Boy's National Tournament in South Australia.

I have completed two years on the national board. I believe the relationships that have been developed, the policies put in place and cohesion established has created a strong foundation for the future. Due to work commitments I will stepping down from the board and wish new Directors all the best as ALA enters a new phase of developing lacrosse nationally.

I would like to thank fellow board members for their support and the time and effort contributed to make the inroads into national lacrosse development.

# HIGH PERFORMANCE – Bob Carter (Men's Manager) & Paul Mollison (Women's Manager)

There has been significant activity in high performance over the past 12 months, with strong progress in program development including policies and position descriptions for the various Australian National teams and development teams. The achievements of the various teams are highlighted below.

### Senior Men's team 2010

The Australian Senior Men's team defeated Japan for the bronze medal, maintaining its ranking as the third best men's team in the world. The team comprised 5 players with past world game experience and 18 new comers, with all players acquitting themselves to the demands of playing consecutive days, and bonding extremely well.

### Indoor Australian Men's team 2011

Rick Benedierks has been appointed as Head Coach with the following staff, Rob MacDougall, Brent Matthews - Assistant Coaches, Jane Edwards - Financial Coordinator, Jeff Williams Strength and Conditioning Coach and Paul Clough - Manager Operations. The final team/squad selection will be held in Melbourne on the 20/21 November. The team will compete at the FIL Indoor World Championship, Prague, Czech Republic from 21 – 28 May 2011.

### U19 Australian Women's Team 2011

The U19 squad have had a busy 2010, outlined as follows – January - Southern Crosse Tournament, Melbourne, April - camp, Sydney, June - Down Under Cup, Melbourne, October – camp, Melbourne. Team selection will occur prior to Christmas, with participation in the 2011 Southern Crosse Tournament in January, Melbourne. The team will compete in the FIL 2011 U19 Women's World Championship in Hanover, Germany, 3-13 August.

The current four year sponsorship agreement with UnderArmour USA, as the 'Official Apparel Supplier' to the Australian Women's Program, will conclude following the 2011 U19 World Championship. UnderArmour has been a tremendous supporter of women's lacrosse and their involvement has been paramount to the success of the women's program.



### U21 Men's and Women's ASPAC teams 2011

Australia will be entering an U21 Women's and Men's development team in the 2011 Asia Pacific Lacrosse Championship. This event will be played at the College Rifles Rugby Club, Auckland from 3 – 8 July 2011. Eligibility is U21 as at 2nd July 2011. Details regarding this event can be found on www.lacrosse.com.au

### U19 Australian Men's team 2012

Head Coach Mark Mangan has been appointed along with Mareena Sear as General Manager. The interview process of applicants for the Assistant Coaches has been completed with announcements to be made shortly. The team will compete in the FIL U19 World Championship in Turku, Finland, July, 2012.

### Summary

2010 has been a busy year for the high performance programs. Congratulations to the Australian Men's team for their bronze medal achievement, and best wishes to the Australian Indoor Men's Team and the U19 Australian Women's team as they prepare to participate in their respective events in 2011.

The current High Performance Manager appointments conclude at the 3<sup>rd</sup> Annual General Meeting. Both Managers thank the ALA board for their support during their tenure.

# TECHNICAL (COACHING & OFFICIATING) – Anne Kingston & Shelley Maher

### Officiating

### **Cost Share Policy at National events**

This was implemented for the first time in the men's national events at the U17 and U19 Championships in July 2010 and for all officials in the U15 Tournament and Senior Championships in September and October respectively. It is anticipated that this will assist in increasing both the quantity and quality of officiating in the future.

### Women

### National

A total of 17 individuals officiated at national events during 2010 (see page 43). An officials database has been established, comprising international, national and state officials.

### International

Nominations for Technical Delegates and Umpires seeking to officiate at the U19 2011 World Championship are due 1 December 2010. ALA ranks the umpires with the first ranked umpire guaranteed attendance. The remaining umpires potential of attendance will be dependent upon the number of umpires required. In addition to the ALA ranking, umpires must attain a minimum of 90% on the written theory exam, and must also pass a fitness test. The FIL accreditation policies (International rating, Fitness testing, and Fitness required to participate at a World Event) are currently being updated and will shortly be available on the FIL website.

The process for Technical Delegate applications is slightly different in that ALA does not rank the applicants. Instead, applications are submitted to FIL, who will select the TDs.

Australia will submit 3 umpires and 4 TD's for consideration by the due date.

### Umpiring pathway framework

An umpiring pathway framework has been revised from a former document and is available on the website. This articulates the various levels of accreditation for umpires and also provides a guide as to the level of accreditation required for the various events, both nationally and internationally, that are available.

### Men

National A total of 37 individuals have officiated at national events during 2010 (see page 43).

### International

18 officials attended the 2010 FIL Men's World Championship (see page 35). Congratulations are extended to Don Lovett (Head Referee), Jason Lawrence (Chief Bench Official) and Mark Polden (Bench Manager) who officiated in the gold medal match. The use of a formal Fitness Test (mandatory for the top Blue Division) and written examination (pass mark of 90+%) were administered to all participating referees. The Australian contingent had the equal highest

number of officials at the event (with England and USA). Other significant representation was from Canada (13) and Japan (5). All other nations (8) provided a total of 12 officials.

### National Technical Committee and ALRA update

With the FIL Men's World Championship 2014 to be held in Denver USA, with a projected 40 participating countries, ALA will need to look ahead to ensure that Australia has the numbers and standards to provide the expected (increased) call for Australian officials from the USA. This will require specific planning and innovation that will be vested with the current National Technical Committee to achieve. To this end, the ALA will also need to consider future team/player numbers, competitions and initiatives strategised within Australia and internationally so that a complementary officiating strategy can be developed.

Preliminary scoping and drafting has commenced for the progression path to a future National Technical Committee (NTC) which will encompass both coaching and officiating for the women's and men's games. This would include completion of Terms of Reference for each layer/level with identification of potential representatives for each of the levels. A broad target for production of the NTC framework is targeted for early 2011 for ALA consideration.

Refinement of the Club Official accreditation for future seasons was reviewed and it was felt that the model developed and successfully implemented by Lacrosse Victoria should be further progressed with an aim of National implementation. There has been high numbers achieved (well in excess of 200 registered Club referees over the last 2 years). This accreditation now has a 2 year duration and consists of coaching and a formal examination. Further refinements will continue to be evaluated (e.g. on-field assessment).

Work is required to progress indoor lacrosse refereeing and this will be tabled for the incoming ALA Board. Mike Slattery has been appointed the Referee in Chief for the ASPAC men's competition (July 3-8, 2011). This is a strategically important competition for Australia to participate in within the Asia Pacific region, for both immediate and long term purposes. Mike will also continue to remain as the ALA Men's Referee in Chief position until February 2011.

For all future world events, the Australian Coat of Arms will be bestowed upon assessors as well as referees (currently only referees receive this).

Finally, congratulations to Rolfe Kraus of ALRA, WA and Alan Chiron, ALRA Victoria on receiving their ALRA Life Membership.

The national rules for men's field as well as the ALA women's FIL variations are on the website. The FIL Women's rules and umpiring manual and FIL Men's Referee Manual and Referee Assessors Manual will be uploaded on the FIL website over the coming few months.

### The Year in Review

The playing numbers in Queensland in 2010 were up on 2009. This was due to the establishment of fully incorporated Brisbane Eagles Lacrosse club. A permanent home was found for Brisbane Eagles and it is very exciting to be part of Mount Gravatt Youth and Recreation Club. It was the first time in a long time that the junior players outnumbered the senior players.

The lack of volunteers is still a big concern. The position of a Development Officer was advertised but unfortunately none of the 10 applicants were suited for the position. One of the senior players managed to help out as a temporary development officer at the local school programs.

The year therefore consisted of training/playing amongst the remaining members without a competition. One women's game was played against a Sunshine coast team towards the end of the season. During the year we had a very enthusiastic approach from a volunteer to get lacrosse going on the Southern Gold Coast. ### The year in retrospect

It is difficult to record events which occurred throughout the 2010 without at the same time contemplating the future. This is appropriate considering that there is normally a change of administrators at about the time when annual reports are being written. The experience and impressions of the outgoing administration is not always conveyed to the incoming administration. This difficulty is often compensated for by the incoming administration being informed generally about the important issues for lacrosse but lacking detail about previous decisions. This report makes no attempt to recount many events of the past 12 months but looks to the future on the basis of past experience.

### National events

The Board of Lacrosse Victoria undertook presenting the national competitions for both men and women and not 'franchising' the event to clubs. This was done for the following reasons:

- It was recognised that clubs had had a demanding year attending to local and national events and another event would be greeted with limited enthusiasm. It was considered unlikely that clubs could match the quality of presentation seen early in the season with the under 17 nationals held at Footscray.
- The event had to be cost neutral to Lacrosse Victoria or make a modest profit. The Board
  was of the opinion that any deficit situation (which would be eventually passed on to
  clubs) was inappropriate. Planning the event was governed by avoiding this outcome –
  at the conclusion of the nationals, this goal was achieved and the event made a modest
  profit.
- The Board of Lacrosse Victoria recognised that there was a prevailing opinion held by some in the lacrosse community that the Board often serves to be punitive rather than creative in administering the sport. There was (and remains) a desire by the Board to be perceived as contributing to the overall presentation of lacrosse in Victoria rather than only making rules. During the course of the week members of the Board were prominent in ensuring that the event ran smoothly and an atmosphere created where it was clear that the administrators of the sport could be seen to work harmoniously with one another and spectators for agreed positive outcomes.
- While it was known that the Board did not have sufficient volunteers to manage the event it was agreed that it would seek assistance from those attending the event as the need arose. Those who were able to give a few hours work on an unscheduled basis were generous with their time and assisted in making the event a success.

During the course of any one year, nationals / championships are held for the following: Under 15 boys and girls (multiple teams from each State), Under 17 boys and girls, Under 19 men, Under 21 women (two in every four years) and Senior men and women.

Given the diminishing number of people available to coach and manage these teams, it is becoming more and more difficult to have representative teams at each event. National events by their nature are for players who are committed to the sport, there is little evidence of a direct relationship between conducting nationals and recruiting players. Given that all states are operating with diminishing numbers of players and growth is an often repeated strategic objective it is implausible that so much effort is directed towards events which contribute nothing to this common objective. We need to remind ourselves that States are solely responsible for the recruitment of players, this is not the charter of the Australian Lacrosse Association. Through a system of rotating allocation of national events to states, much effort is given by states to conducting national events which (as has been asserted) focuses on outcomes which do nothing to achieve (or promote) growth. This anomaly cannot continue!

The problem is further exacerbated when international events in the same year consume the attention and resources of senior players. The most recent indicator of this issue was the inability of Western Australia to field a team at the senior championship. States need to insist that the Australian Lacrosse Association give attention to the presentation of national events not at the expense of using valuable resources which should be directed towards halting the descent of lacrosse into oblivion.

At a national level there needs to be consternation about Australia's continuing decline in numbers and the reverse of this situation (i.e. impressive growth) occurring in every other lacrosse nation.

### Victorian lacrosse

Consistent with other states, Victorian lacrosse is in long term decline. Despite having identified growth in numbers as the major strategic decision, numbers continue to decline with 2010 having been the greatest decline in memory. A number of initiatives have been embarked upon in an attempt to correct this decline in playing numbers.

- Funding the establishment of lacrosse in Bendigo. During 2010 steps taken in 2008 and 2009 and in 2010 have received modest consolidation. The fielding of a senior Bendigo team participating in metropolitan competition is a significant step in the overall development of Bendigo
- During 2010 also, development of primary schools was also consolidated into four schools. Subject to further funding from the Victorian Government it is intended that these four schools will field underage teams in the Bendigo area and play during the week as school teams.
- Future development is aimed at transforming school teams into club teams. The issue is not about recruiting sufficient players but about developing flexible structures which will retain and consolidate teams who wish to pursue sport beyond primary school or secondary school.
- The input of local interests is fundamentally important to the expansion of the sport.

### Warrnambool

A similar initiative is being prepared in Warrnambool with the experience gained in Bendigo being used to develop increasing participation in the sport. While Bendigo is sufficiently close to Melbourne to allow participation in metropolitan lacrosse and for metropolitan teams to travel to Bendigo in the short term a similar strategy is not possible (because of distance) in Warrnambool.

It is intended that in both Bendigo and Warrnambool competitions will be established which are not connected to the Melbourne network of clubs. The decision to hold a 'Lacrosse Classic' in Warrnambool while dependent on a commitment by the Warrnambool Council is also (subject to State Government support) dependent on the Victorian lacrosse community supporting the presentation of a major lacrosse event early in 2011. Monday 4<sup>th</sup> April - Sunday the 10<sup>th</sup> April. Adequate steps will be taken in 2010 to link exposure in Warrnambool with primary schools and Deakin University.

The developments in both Bendigo and Warrnambool will be closely monitored. The decline in the number of players in metropolitan Melbourne is an indicator that alternatives need to be found. This is despite impressive efforts by some clubs to intensify player recruitment.

Victoria is fortunate that unlike most other States it has a number of large regional centres where a critical mass (the population numbers) allows a minor sport to be reasonably certain that it can take roots and grow. Looking back the regrettable decline in player numbers motivates consideration of the future.

### Lacrosse in private schools

For some time Lacrosse Victoria has understood that historic patterns of recruitment are either not effective or minimally effective for the level of input. While a governing body is limited in what it can do to recruit players (clubs are the front line for recruitment) there are instances where an association can be more effective in implementing recruitment strategies – especially when multiple organisations are involved.

A recent initiative to approach selected private schools has been proposed by the Association. Essentially this means that preparatory work can be undertaken by the Association. Liaison with about seven schools will be initiated and ongoing contact with schools continued by clubs. A new paradigm is required for clubs to accept that private schools have a pride in sporting teams being linked to the school in much the same way as clubs encourage commitment to the club structure, club colours and club teams. Preparation for a fully documented approach to private schools will continue in 2011

### Increasing complexity of administration

For a number of years, Lacrosse Victoria has identified that the complexity of administration has added dramatically to overhead costs. A few examples:

- The need to establish and maintain complex data bases to document player participation and personal details. While systems are now readily available, maintaining accuracy and relevancy is an overhead for both clubs and the Association.
- Communication and the need to know results in costly websites and the necessity to be current at all times. Again the maintenance of websites is an onerous requirement for all.
- An unreasonable amount of time is given to assessing where fines are to be applied and following up where there is an unwillingness to discharge fines. The amount of disputation regarding fines grew to such proportions some years ago that Lacrosse Victoria developed a policy of "pay the fine' and then challenge whether the fine had been appropriately applied.
- Lacrosse Victoria has had a long experience in knowing that emails and information appearing on Association's website is frequently not transmitted to players and club members. This often results in the necessity of telephoning key people to ensure that critical messages are relayed.

• Disputation about player eligibility to participate in finals reaches epidemic proportions prior to and during finals. It is estimated that up to 30 percent of office time is given to unravelling disputes of this nature in the period immediately before finals.

The light at the end of the tunnel is that once teams have assembled to compete in weekend to weekend lacrosse, all thoughts of disputing are replaced by a focus on the afternoon's challenge.

Given the role the ALA has adopted in keeping abreast of policy requirements of Government, Lacrosse Victoria sees the work done in developing policy as an opportunity to avoid devoting time to independently developing policy. This is appreciated by Lacrosse Victoria. The downside is that policy adoption becomes a 'tick the box' exercise without much commitment to the principles which are inherent in the policy.

It is Lacrosse Victoria's recommendation that ALA moves beyond the pressing need for the development of policy and address the most important matter requiring extensive consideration, namely increasing the number of players in the sport.

### Some conclusions

Lacrosse generally and Lacrosse Victoria needs to focus carefully on reversing the falling numbers of players. The fact that all other lacrosse playing nations are growing (often in double digit numbers) should cause us to examine ourselves more closely.

We need to develop a corporate mentality that we are equally responsible for growing lacrosse in this country. While we have a seemingly endless succession of ideas, these ideas are rarely translated into positive outcomes. We prefer to argue about whether the opinion of others is 'the way to go'. The length of time it took to get on with sound governance at the national level and similar episodes within Victoria does little to direct the considerable energy of the lacrosse community into plans which would be productive for all.

Victoria calls on all states to support the growth of lacrosse through the Warrnambool initiative. Events of this nature are not confined to Victoria and it would be pleasing to support similar initiatives generated by other states.

The major challenge facing lacrosse in WA into the future is combining the processes of running the game, expanding to new areas including regional WA, increasing costs for state and regional teams travelling teams, increase the standard of coaching within WA and increasing the number of referee's/umpires to list a few .

All board members are thanked for their tireless efforts and support throughout the year. Gary Kennedy will stand down at the 2010 AGM and thanks LWA (also the previous WALA boards) for the honour of being the President. Lacrosse members past and present are encouraged to get behind this great game of ours. The incoming board is wished all the best along with all the challenges in the 2011 season.

#### Notes to the Financial Statements

#### Note 1: Statement of Significant Accounting Policies

The financial statements cover Australian Lacrosse Association Ltd as an individual entity. The Company is limited by guarantee, incorporated and domiciled in Australia.

#### **Financial Reporting Framework**

The entity is not a reporting entity because there are unlikely to be users of the financial report who are unable to command the preparation of reports tailored so as to satisfy specifically all of their information needs. Accordingly, a special purpose financial report has been prepared.

#### **Basis of Preparation**

The financial report has been prepared in accordance with the requirements of recognition and measurement aspects of all applicable Australian Accounting Standards adopted by the Australian Accounting Standards Board.

The financial report does not include the disclosure requirements of the following pronouncements having a material effect:

#### **Basis of Measurement**

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non- current assets.

#### **Functional and Presentation Currency**

These financial statements are presented in Australian dollars, which is the entity's functional currency.

#### **Use of Estimates and Judgement**

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

#### b. Revenue

Revenue is recognised when the Company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Revenues are recognised net of the amounts of goods and services tax (GST) payable to the Australian Taxation Office.

The Company's activities are funded by grants received from the Australian Sports Commission and membership fees.

Grants received on the condition that specified services are delivered, or conditions are fulfilled, are considered reciprocal. Such grants are initially recognised as a liability and revenue is recognised as services are performed or conditions fulfilled. Revenue from non-reciprocal grants is recognised when received.

Membership fees are recognised upon the delivery of the service to the members.

Interest revenue is recognised on an effective rate basis taking into account the interest rates applicable to the financial assets.

Membership fees recognised revenue from the rendering of a service is recognised upon the delivery of the service to the customers. All revenue is stated net of the amount of goods and services tax (GST).

#### c. Income Tax

The entity has received an endorsement from the ATO confirming that it is exempt from income tax.

#### d. Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the balance sheet.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST components of investing and financing activities, which are disclosed as operating cash flows.

#### e. Payables

Accounts payable are recognised when the entity becomes obliged to make future payments resulting from the purchase of goods and services.

#### f. Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

#### g. New standards and interpretations not yet adopted

The following standards, amendments to standards and interpretations have been identified as those which may impact the Company in the period of initial application. They are available for early adoption at 30 June 2010, but have not been applied in preparing this financial report.

#### AASB 2007.8

This standard makes technical amendments to a number of Australian Accounting Standards arising from the revised AASB 101 Presentation of Financial Statements that was applicable to annual reporting periods beginning on or after 1 January 2009. No material impact on the Company is expected. AASB 2007-8 is applicable to annual reporting periods beginning on or after 1 October 2009.
