

Message from the Australian Sports Commission

The Australian Government is committed to getting more Australians participating and excelling in sport. Sport not only inspires and unites us as a nation, it also motivates us to get involved and active.

The staging of the Olympic and Paralympic Games is an exciting time for all Australians, and highlights the substantial contribution of sport to our community, from athletes competing at the Games to those involved in weekend club competition and social play, as well as parents and volunteers.

Australia's performance at the London Olympic and Paralympic Games is the culmination of extensive longterm efforts across the Australian high performance system. It is two years since the Australian Government delivered its new vision for sport in 'Australian Sport: The Pathway to Success' and substantially increased ongoing funding to the Australian Sports Commission. Since then, we have focused on implementing our new plans, delivering key programs, supporting national sporting organisations (NSOs) to deliver participation and high performance outcomes (as well as building their capacity), and building collaboration, alignment and effectiveness within the Australian sport sector.

The announcement in the May 2012 Budget of the continuation of the Active After-school Communities program will ensure we carry on providing primary school-aged children with a positive introduction to sport. We will continue working with sporting organisations at all levels to ensure the program provides maximum value to sports and supports the transition of program participants into local clubs.

Linked to the London Olympic and Paralympic Games, the Prime Minister's Olympic and Paralympic Challenges will encourage and inspire children to participate in sport and to get active, have fun and earn rewards. This initiative, as well as participation funding programs delivered by NSOs, continues the Australian Government's commitment to ensuring more people can access sport and all the benefits it provides.

The support received from the Australian Government for Australian sport is essential and plays an integral role in connecting our young sporting participants with their dreams of podium success in the future.

This is an exciting and challenging time for Australian sport. The Australian Sports Commission looks forward to working with sporting organisations, state and territory institutes and academies of sport, and state and territory departments of sport and recreation, to promote access to, and participation in, sport across the community, and supporting Australia's continued sporting success.

President's Report Mike Slattery



This is the fifth Annual Report since the establishment of the Australian Lacrosse Association (ALA) in March 2007, which In partnership with its Members, the State Associations, is responsible for the management and sustainable development of the sport of lacrosse nationally. The ALA also has a responsibility to manage relations internationally through the Federation of International Lacrosse (FIL) and the Asia Pacific Lacrosse Union (APLU).

At the national level the need for governance performance has been apparent to the ALA Board from the outset. It has been discussed and agreed at regular intervals with Member Associations (MAs). Recognizing the notion that 'better practice' in governance has changed over the years the ALA moved to ensure its governance practices continued to be current 'best practice' and improve over times ahead.

The on-going support and guidance of the Australian Sports Commission (ASC) has long been integral to the sport of lacrosse in this country, and the ALA remains indebted to the Commission for their recognition and continuing funding (\$50,000) through a Sport Participation Grant. The ALA is now signatory to the Sport Collaboration Agreement (SCA). The ALA prides itself on its two-way communication with the ASC and continues to work closely and productively with the ALA Sports Partnership Manager, Mr. Andrew Pratley. During 2012 members had the opportunity to meet with Andrew at various ALA activities including the October President's Forum and various ALA Board Meetings. The ALA continues to meet all compliance documentation and reporting obligations to the ASC in a timely manner with positive outcomes and a joint commitment to the future. There are a number opportunities (e.g. 2012 National Sport Participation Workshop, 14-15 November 2012) that the ASC makes available and which the ALA is most willing to benefit from attending.

Policy formulation remains an on-going critical process of the ALA, and in the past saw an 'ALA Board Induction Policy,' and 'ALA Board Charter' compiled and adopted in order for each newly elected Director to rapidly become a productive contributor to the Board, and to gain an understanding of the ALA's objectives and operations in order to facilitate the decision-making processes. The Board also recognized the need to address some of its own internal governance challenges, and 'Board Performance' and 'Director Performance' evaluations have been carried out.

The production of the 2012 Costed Operational Plan provided the Directors with operational and budgetary guidance throughout the year and Directors have been required to report against this Plan at all meetings and have worked within its framework. The ALA Strategic Plan has been revised, updated and adopted during 2012 and now covers a three-year cycle (over 2012-2014).

At the 2011 AGM Directors Fiona Clark (Past President since inception of the ALA Board) did not seek re-election; Jan Jackson (past Director since the inception of the ALA Board) did seek re-election. Those elected were Jan Jackson and Graham Sharp. Shortly afterwards Director Lynton Arscott had to resign due to health issues. An interim appointment was made by the ALA to replace Lynton by Glenn Morley (who would undertake responsibility for his prior KRA of Coaching). Shelley Maher (prior founding ALA Director) has continued to do some ALA project work (e.g. web site) from her current domicile in the USA. Fiona Clark (prior founding ALA Director) has also continued to do some project work (e.g. Recognition and Awards Committee Chair).

With the adoption of a motion to make a change to the composition of the Board at the 2010 SGM the ability to appoint two Independent Directors saw the ALA able to target two

key positions which were lacking - High Performance and Marketing. This shall now allow the ALA formal independence by virtue of the representative nature of these appointments, and shall greatly enhance the skill-sets and knowledge on the Board, thereby bringing new insights and perspectives into the Board's discussion, debate and decisions.

It was indeed encouraging to attract the successful candidate of Paul Mollison into the role of High Performance Director of the ALA, effective from December 2011. Paul brings an outstanding history and positive approach to this area of High performance (with the bonus of significant lacrosse experience) to that role.

The Marketing Director position was successfully filled in August 2011. It was exciting and positive for Australian lacrosse that the ALA has been able to attract an interested person outside of the sport who has a broad marketing experience across a range of industries with specific expertise in new product, centre and venue launches, brand positioning and events. This two-year appointment for Diane Harari was made in August 2011 to focus upon identifying and maximizing opportunities for the ALA to generating additional income, and to promote the sport through increased marketing and profile awareness. Unfortunately, due to work and family demands, Diane resigned in April 2012 and a replacement for that role is currently being progressed through its final stage.

Without sufficient funding to employ a part-time CEO (a position which therefore remains 'on hold') there is a need to off-set the ALA administrative responsibilities to provide increased support to the Board. The vast amount of work-load being undertaken by the ALA Administration Director was the catalyst to the Board determining that a part-time paid Executive Assistant be employed. This position is on a two-year contractual basis and is a paid position (varying from the voluntary Directors role of the Board). Primary responsibilities include website administration, establishment of a national data base, and acting as Board Secretary at meetings. The delineation between the roles and responsibilities of the Administration Director and the Executive Assistant, supported by agreed levels of delegations, will ensure that the layers of decision making across the sport are appropriate, clear of conflicts and in the best interests of all key stakeholders in the This position has been advertised internally sport. and externally (www.sportspeople.com.au) and is nearing a conclusion.

One of the ALA's biggest disappointments for 2012 has been the Board's inability to implement the much needed sub- committee structure, with Chairs to be appointed, who shall report directly to the respective Directors of the Board. It is hoped that these committees shall be established for all areas of responsibility (basically KRA areas from the Operational Plan) during 2013. The ALA shall then be able to gradually move to becoming more of a Strategic Board as opposed to a mainly Operational Board. Despite the keenness of Directors to continue developing the sport a lack of time continues to be identified as the most important constraint preventing the Board from doing all that it wants to achieve.

Outcomes are all important to the ALA; whilst effective and progressive management of the Association, with focused objectives and clear strategies for achieving this is vital to grow, develop and promote the sport on a sustainable basis, so is the need for Directors to undertake professional development for the sustainability of these activities. Accordingly various courses and seminars have been attended this past year.

The 4th President's Forum was held in October in Melbourne in conjunction with the U/15 Nationals. The ALA acknowledges that conducting such forums is an on-going process

which will continue to evolve and be refined over time. These forums have provided a platform for analyzing where governance change is needed, what options are available to meet these needs and what tasks should be undertaken to underpin development opportunities throughout the country.

A High Performance Forum was conducted in October in Perth, in conjunction with the Seniors National Tournament.

The participation of the Australian U19 Men's Team 2012 in the FIL U19 World Championship was not as successful as was originally targeted. While they finished fifth in a tightly contested event this was below the target that had been set and aspired to, in conjunction with the ALA.

Actions considered integral to the Board's responsibilities in order to continue to manage relationships with a number of external stakeholders, and to maintain Australia's position as one of the leading and most influential nations aligned to FIL, included representation at International meetings and on International committees. The 2012 FIL General Assembly in Amsterdam during June 2012 was represented by Mike Slattery. Australia is also represented on the following FIL committees - Women's Rules with Jan Jackson recently appointed as Committee Chair and Paul Mollison being a Committee member, Men's Officiating via Mike Slattery, and Men's Rules per Duncan McKenzie.

In July 2011 in New Zealand Mike Slattery was elected President of APLU (Asia Pacific Lacrosse Union), with Fiona Clark appointed Executive Director. This will continue over a four year role and indicates the commitment that the ALA has made to supporting lacrosse and its development in our Asia Pacific region. The ASPAC (<u>ASia PAC</u>ific) Tournament for 2013 will be held in Beijing, China and the ALA has committed to sending both men's and women's U/21 teams.

The on-going appointment of MGI Perth (now Nexia Perth), as the ALA's Auditors, was made in 2011. The effective chartered accounting services of R. J. Hartnett & Associates, has ensured the Association has met its legal and compliance requirements as well as operating in a financially sound manner. The full and audited financials for 1 July 2011-30 June 2012 are detailed in this annual report.

National Championships have been conducted in WA, SA and Victoria this year, which have provided the opportunity to showcase our sport in these member states.

During October, in conjunction with the Senior Nationals in Perth, the ALA hosted the second 'ALA Recognition Dinner'. This was a prior innovation by the ALA Board to recognize past and present valued contributors to the men's and women's game. This also provided the ALA the opportunity to profile the 'evolving organization,' to take a look into the future with the steps being undertaken to Olympic representation, and to seek the interest of lacrosse enthusiasts who might be interested in assisting with special projects in the future. The evening was extremely successful and shall now continue on the ALA annual event calendar. From next year (of 2013) the established ALA Recognition Committee will be fully operative and make recommendations for formal recognition of appropriate contributors to the sport of lacrosse in Australia.

The ALA continues to progress moving beyond the past legacy of (men's) Lacrosse Australia (LA) and Women's Lacrosse Australia (WLA), and it was during April 2012 that the

de-registration of LA was concluded as a final unification step. Other key concluding points this year were:

- The Men's Australian Team Trust Fund was transferred to ALA for future management
- The Men's competition trophies were transferred to the ALA for future management
- The ALA has established and will grow a Development Fund which will require the ALA to contribute \$129,000 for injection into a single entity, capital protected, nongender based foundation
- The ALA & prior LA/ALF (Australian Lacrosse Foundation) development funds will then be combined to support the development of the sport, once an equal amount is achieved
- The resignation of ALF directors and de-registration of the ALF will then take place, and a new lacrosse foundation established and the ALA shall then be able to operate as a NGB independent of that legacy.

I wish the incoming Board (following the elections to be announced at the ALA AGM in December 2012), all the best of success and positive outcomes. I further encourage the new generation of lacrosse enthusiasts to contribute to the transition as the ALA continues to build a dynamic and sustainable organization whilst growing into the future of Australian sporting organizations and participants.



Marketing Report

A Director of Marketing, Diane Harari, was appointed in August 2011 to give greater focus on improving the growth and awareness of Lacrosse within Australia. Unfortunately, Diane resigned from the ALA Board in April 2012 due to work and family commitments.

ALA is currently in the process of appointing a new independent director to the position of ALA Director of Marketing. Interviews are being conducted with a short list of three applicants during November. It is planned to make an appointment to this role by the beginning of December 2012.

Work was begun on a marketing plan to address how the ALA can grow participation numbers and improve its overall profile at both a state and national level.

The plan is to include

- Creation and sharing of resources among all Member Associations
- Use of social media tools
- Better collaboration between Member Associations
- Increased communication
- Sponsorship opportunities progressed
- Publicity generally for lacrosse and particularly for any specific opportunities

A Twitter account and Facebook site has been established, and one edition of the ALA newsletter has been achieved.

The ALA website is also slated for a revamp to ensure that its rich content is more readily accessible to users. This will continue to operate under the SportingPulse format. Work on updating/revamping the website is still to be achieved although preliminary work is underway.

Collaboration will need to take place between the High Performance programs and Marketing to create appropriate sponsorship packages, to assist with publicity and in the area of fundraising.

Each Member Association was requested to provide a contact within their state to link each Member Association to the ALA area of marketing to enable cooperation and the sharing of ideas. This work between ALA and its Member Associations is to be picked up by the new Director of Marketing.

ALA is thrilled to have announced the ALA 'tag' line **"Lacrosse. Not just different. Better"**. This was announced at the ALA 2012 Recognition Dinner held in East Fremantle in October during the ALA 2012 City of Cockburn Senior Championship. At the dinner each guest was given a gift of an ALA magnet and an ALA car sticker.





High Performance Report Paul Mollison

The program of Australian Teams remains the prime focus of the ALA high performance portfolio. All Australian men's and women's teams now operate under identical principles and policies. The ongoing development and improvement of High Performance policies is undertaken following each team program and performance review.

High Performance Teams

U19 Australian Men's Team 2012

Following many months of preparation, the U19 Australian Men's Team departed for the USA in July for a tournament in Germantown Maryland and then a training camp at Loyola College also in Maryland. The team then headed to Turku Finland for the FIL 2012 U19 Men's World Championship. After loses to USA, Canada and Iroquois and a disappointing 10-9 lose to England, saw Australia out of the top 4 division. Victories were then achieved over Finland and Czech Republic in the 5th Vs 6th playoff for 5th placing overall.

For a second successive U19 World Championship, the U19 Australian Men's Team has finished in 5th place. The decline from previous events of our silver and bronze achievements will be addressed by ALA in the coming months and incorporated into the planning for the 2016 U19 Australian Men's Team program.

Australian Women's Team 2013

The beginning of 2012 saw the 2005 World Cup winning Head Coach, Max Madonia, back at the helm of the 2013 program. The appointments of Trish Adams as Assistant Coach and Kate Simpson as Manager followed soon after. With several training camps and local tournaments throughout 2012, the Australian Squad travelled to San Francisco USA in October to compete in the US Lacrosse Stars and Stripes Tournament. With competing National teams, USA, England and Canada, this opportunity provided an experience to our player's that is usually only gained once every four years at World Cup. In the final game, ESPN provided full coverage and was available in Australia via ESPN3 for those with a Foxtel account; Australia was defeated by USA 12-11.

With the Australian Squad attending San Francisco, it was unfortunate that several players were not able to attend the Senior Nationals in Perth the following week. The timing was unfortunate and will be avoided in the future. Selection of the 2013 Australian Team is expected following a three game series with Dartmouth University, to be held in Adelaide, 20, 21 & 22 December. Other team personnel appointments are: Physiotherapist Scott Smith, Doctor Megan Barnet and Analyst/Video Melissa Williams.

Australian Men's Team 2014

With Head Coach, Glenn Meredith, appointed in November 2011, the early part of 2012 saw the appointments of Assistant Coaches, Peter Brown, Murray Keen, Chris Baker and Manager John Keesing. The Squad commenced with state based sessions followed by Camp #1 at the conclusion of the Senior Nationals, in Perth during October.

Other team personnel appointments are: Physiotherapist Rick Tillotson, Team Analyst Rod Ansell, Statistician Phil Ackland, Sports Science Co-or Ted Polglaze, Strength & Conditioning Stuart Cormack and Trainer Romy Ansell.

U21 Australian Men's and Women's Team Program

The recently announced initiative of sending U21 Australian Teams to the bi-annual Asia Pacific Lacrosse Union (APLU) ASPAC Championship, will help to bridge the pathway between U19 and senior Australian Teams. The benefits will be gained by players, coaches and officials alike.

The 2013 U21 Australian Teams will compete in the 2013 Friendship Games, 14-16 June in Tokyo Japan en-route to the 2013 ASPAC Championship, 21 -26 June in Beijing China. Coaches will be appointed in November followed by the announcement of squads. State based training will take place in December and January, with a selection camp in late January.

High Performance Meeting

The recent High Performance meeting at the Senior Nationals in Perth, saw attendance by a majority of senior state team and Australian team coaches. Several areas of our sport were discussed, with the main concerns expressed as growth, recruitment and coach development.

Other areas addressed included:

- Timing of the Senior National Championship to provide assistance to our Australian Team preparation;
- Senior Nationals format;
- National Coaches Forum, schedule in October during the U15 Nationals.

These items have been addressed by ALA and are included in the 2013 schedule.

Women's

The Women's National Technical Committee formed during the 2012 season with a start made in progressing towards formalised assessments and coaching of umpires at national events. The object of this is to encourage similar assessments and coaching of umpires at domestic levels. An initial focus on improving the profile of technical directors will see a lifting of coach / mentoring of umpires with a view to drive recruitment of both umpires and importantly technical directors so that the vital role of providing officials is progressed to enable improvement in the presentation of our game.

Growth & Development Report Mike Slattery

Introduction

Building from a 2010 commitment, wherein the ALA planned to support projects that would provide targeted participation and a growth in grass-roots numbers, the ALA is now in a position where it has commenced to develop the Growth and Development area with 2012 activities. These will lead into further progression through 2013 and beyond.

Overall

The targeted activities (per KRA2) for the ALA Board continue to be a matter of high priority and ultimate purpose for the responsible ALA Director's role and its deliverables. They do require dedicated effort and Australia wide teamwork to implement best practices and obtain economies of scale. Interestingly, but not surprisingly, this need to grow and develop lacrosse in Australia is shared by each and all State Associations.

The initiative of a Growth Workshop was hosted during October 2012 by the ALA and enthusiastically attended by enthusiastic representatives of all Member Associations. As a result an agreed Action List of 21 items was produced with an Australian wide focus and a commonality of purpose. This will be implemented under an ALA Advisory Council, which has been subsequently established, with representation and endorsement by all MA organizations. This ALA Advisory Council has an agreed Terms of Reference and it will progress goals, tasks and actions into an agreed plan which will be progressed at the maximum rate possible.

The ALA will continue to work and tie in with all Member Association junior development committees/plans/working groups as well as externally with pertinent bodies (e.g. the ASC). Internally the ALA will closely co-ordinate between ALA Marketing (to maximise any potential sponsorship), with ALA Competition (to ensure maximum participation opportunities) and with ALA Coaching & Officiating (to ensure maximum support is available and provided).

Particularly relevant will be establishment of the capital protected trust fund whose earnings are intended primarily to be directed to junior development of lacrosse in Australia. This is targeted to take place in late 2012 and be operative from the start of 2013 onwards The core challenge thereon will be new fund raising which can then be undertaken to grow this trust fund – and hence the earnings to be invested in the growth and development of lacrosse in Australia. This also will produce additional opportunities (e.g. sponsorships, donations, bequests, etc.) for such fund raising with the outcome producing ever increasing financial support, outside of using operating revenue, for the growth of this great game.

Targets

Overall the major targets are defined as:

- Grow the numbers of lacrosse players in Australia consistently and into the future;
- Encourage co-operation and sharing of ideas and resources between Members Associations;
- Ensure that 'best practice' for Growth and Development is identified and then employed throughout all Member Associations in Australia.

Goals and Tasks

Goals were produced (nine in total) and Tasks in support of identified (ten in total) and they have all commenced being worked upon. Those Goals and Tasks will be developed and progressed in the future operating year(s) by the ALA Advisory Council.

Key Matters

The key matters that were noted during the setting of this Growth and Development plan include:

- Retention of players throughout their teenage years into senior competition
- Creating baseline statistics of lacrosse participation in Australia for all of planning, recording and targeting purposes as well as reporting which must be accurate and timely
- Obtaining the economies of scale that are potentially available and can have benefits demonstrated (e.g. a National Insurance Scheme, as was introduced by ALA for season 2012)
- Review existing programs, e.g. ASC's AASC (Australia After Schools Competitions), to identify common potential
- Accurately record all payers/coaches/officials/supporters/volunteers/etc. involved with lacrosse – ideally within a National Database initially and in future years (so that we can accurately and responsively monitor and report statistics) to achieve and measure fully all lacrosse participation on Australia
- Identifying opportunity areas for junior involvement with lacrosse devoid of historical precedent (e.g. time-of-year, schools competition, phased entry into seniors, etc.)
- Seek any input from other countries/areas that have been successful in growing lacrosse participation
- Ensure all involved coaches and officials are educated and accredited to support the involvement of junior players and meet all requirements in support of junior players (e.g. Working With Children accreditation)
- Create a national database of Australian lacrosse coaches/players/officials that are participating overseas and ensure leverage of that knowledge both currently and in the future

In summary the major conclusion that is drawn is that, via ALA and the Member Associations, we must create and have at our immediate disposal a National Database of all lacrosse participants on year-by-year basis – to record, monitor, plan and report for the future. Hence an identified need for us all to utilize the existing capabilities of the common SportingPulse database (which ALA and all Member Associations use, as funded by the ALA). This has resulted in a request and initiatives for all Member Association Clubs to utilize the Sporting Pulse On-Line registration capabilities from the start of season 2013 (which have been proven, with lessons learnt, in pilots during seasons 2011 and 2012).

Summary

The magnitude of this Growth & Development area is both huge and critical. The ALA Board has fully endorsed the progress to date and the future plans of the ALA Director overseeing this area.

It is planned and committed that this area of Growth and Development will be progressed significantly over the next year. Progress and plans are expected to be positively updated in next year's report.



Coaching Report Glenn Morley

As a mid-season appointment to the role of Director of coaching, I have found myself in a steep learning phase within the portfolio. A majority of my time has been spent looking over previous documents and processes, as well as acquainting myself to the policies and procedures for the ALA Board.

For each of the major objectives within the KRA a variety of review and research has been undertaken with solid planning in place for development in 2013 and beyond.

Objective: Ensure quality coach education programs for all levels

The club coach course continues to be well received and delivered within the lacrosse community. It has provided a valuable first step in formal coach accreditation and we are looking to build on its effectiveness through the training of presenters in QLA, NSWLI and LTas.

The post course-follow up and the procedures / policies around the accreditation will be key outcomes upon the completion of the Club Coach review which will be completed in December.

The further development of the Advanced Coach Course (Level 2) is under way; with the course being currently developed it is envisaged the course will be presented to the Australian Sports Commission by February to be implemented in the 2013 season.

In the courses development best practice has been researched from US Lacrosse, the Canadian Lacrosse Association and the AFL to ensure that the course is dynamic and of the highest standard to ensure a sustainable coach education pathway.

Following the completion of the Advanced Coach course we will be addressing the High Performance course and look to determine the best structure to develop and run the course.

Objective: Establish a centralised National Database of registered/ accredited coaches

The current database is currently under review with a full operations manual being developed to partner it. The database is an area where currently I haven't been able to contribute a lot of time, and a key area of focus to close out 2012.

Another key component within the database objective is to develop a strong network between all accredited coaches. This is to be achieved through a coach advisory council who we anticipate will sit over similar groups within each of the state.

A key role of the advisory council will be to assist the ALA Director in the direction and implementation of the coaching courses along with the development of opportunities for continuing education of coaches through club/state seminars and workshops along with the development of a national Coaching conference (to be held in conjunction with an officials conference)

National Coaching and Officiating Conference

Planning for the ALA's inaugural Coaching and Officiating Conference is underway and scheduled for March 1-3 to be held in Victoria, the conference will provide a big step forward

in coach education and will provide all current accredited coaches an opportunity to further their knowledge through a variety of presentations from current and former Australian Coaches and players along with experts in the fields of coaching, sports science.

The conference will be aimed at all level s of coaching with a variety of presentations to meet every need.

Key Focus for 2013

- Fully operational coaches database
- Advanced Coach Course, developed, approved and delivered
- Conduct the National Coaching Conference Victoria, March 1-3 2013
- Coach Advisory Council operational
- Approval of Club Coach presenters in each MA

Long Term Strategic Aims

To complement the short term focus of projects in 2013, a review of the Strategic objectives and measurables in the KRA were also undertaken in 2012 when the ALA Strategic Plan was reviewed.

The most important measurable will be the compulsory accreditation of all coaches by June 2014. This is a big step forward in our commitment to coach education, a result of which must be a quality education pathway developed through the Club, Advanced and High Performance Coaching Courses

Objectives:

- Implement national coaching accreditation and education programs
- Produce quality and appropriate accreditation programs at Level 2 and Level 3
- Enhance the consultation of coaches in the review and refinement of the rules of lacrosse
- Provide pathways and opportunities for development

Measurables:

- All coaches must be accredited coaches by 30 June 2014
- Establish a national coaching Advisory Council by 2013
- Coach materials and resources are available to be provided
- Design and implement an approved Level 2 accreditation course, through the Advisory Council, by 2013
- Design and implement an approved Level 3 accreditation course, through the Advisory Council, by 2014
- Conduct a national Coaching and Officiating Workshop in early 2013



Competition Report Janet Jackson

ALA events were conducted jointly for men's and women's Senior and Under 18 Championships and the boys' and girls' Under 15 Tournament. The work and dedication to ALA events by hosts Lacrosse Victoria, Lacrosse SA and Lacrosse WA and their respective Championships and U15 Tournament Coordinators are gratefully acknowledged and greatly appreciated as without their support these events could not be successful in showing the excellence that competition brings to our sport.

The **Southern Crosse Tournament** was not played this year but will return to the competitions calendar in January 2013.

Australia-Wide Fairest and Best Players

Fairest and Best Players Australia-wide in the most senior men's and women's State competitions home and away qualifying round matches, based on votes awarded by match umpires, the **Isaachsen Trophy** (men) and **Shelley Maher Trophy** (women).

The **2011 Isaachsen Trophy** for the **fairest and best player Australia-wide** was won by **Matt Diver** (Western Australia).

The **2012** Isaachsen Trophy for the fairest and best player Australia-wide was won by Rob Stark (Victoria).

The trophy was donated by Cedric Isaachsen to the Australian Lacrosse Council (ALC) in 1963. He was a remarkable man who had a distinguished military career, rising to the rank of Lieutenant Colonel and earning the honour of Companion of the Distinguished Service Order (DSO), followed by a distinguished legal career. Mr. Isaachsen was President of ALC 1962-65, then Vice-President for 14 years until 1979. He was elected as a Fellow of the ALC in 1994. He lived in South Australia and died in 2009, aged 97 years.

The inaugural **Shelley Maher Trophy** for the **fairest and best player Australia-wide** was won equally by **Beth Varga** (South Australia) and **Rachel Kirchheimer** (Victoria).

The trophy is named in honour of Shelley Maher and was instituted in 2012 by the ALA. As the last President of Women's Lacrosse Australia (2001-2009) Shelley committed to excellence in all areas of administration. In her home State of Victoria Shelley was President of Women's Lacrosse Victoria (1998-2001), and was elected a Life Member in 2001, and in 2009 of Women's Lacrosse Australia. She was active as a player with Williamstown Women's Lacrosse Club and represented Victoria in 7 senior competitions (1997, 2001, 2002, 2003, 2004, 2005 & 2007). Shelley was an ALA Director (2007-2010) and now resides in the USA where she remains active in lacrosse as the Women's Director on the Federation of International Lacrosse.

Congratulations are extended to Matt, Rob, Beth and Rachel on achieving the pinnacle fairest and best player award in Australia.

Coaching

With assistance of a grant from the Office for Recreation and Sport and in response to Club's requests LSA offered free of charge an "Essentials for Coaching Children" course in August 2011. This is a basic course designed to assist those venturing into a coaching role for the first time, particularly at U8 and U11 level. Fifteen people attended and received a certificate. The same course will be offered in March next year for Season 2013 Coaches. We are very keen to get all Coaches accredited and this is the first step on the ladder.

Development

Development activities and consequent recruitment, leading to numbers in the game were a big priority in 2012.

Specific development activities included

- Clinics at identified schools
- High School competition boys and girls 14 teams, 138 participants
- University Competition 5 teams and 28 participants
- Two lightning carnivals for primary schools. 35 teams and 61 teams. Was great to
 have the ABC program Behind the News at one of these and see a great segment
 about lacrosse go to air
- Participation at various external organisation events e.g. Council run events, ACHPER.

Events

Lacrosse SA was pleased to host the ALA National Under18 Girl's and Boy's Championships in 2012. It is becoming increasingly difficult for Clubs to come up with the resources to run these events, and this was run largely by small voluntary group and Lacrosse SA staff at LSA Headquarters Barratt Reserve. From our perspective the combining of Boys and Girls for this age group at this time of year seemed to work very well.

Officiating

The recruitment of Officials is an ongoing issue and the numbers of officials available for both the Men's and Women's games seems to be decreasing every year and 2012 was no exception. It is not a role many seek to take on, and we very much appreciate those who do, but family commitments, work relocations and retirements take their toll on numbers, and the capacity of the respective organisations to provide the administration and training required.

Highlights

For Lacrosse SA, 2012 was undoubtedly highlighted by the recent victory of the Red Men at the ALA National Championship in Perth, closely followed by the victory of the Under 15 Girl's Storm team at the National Tournament in Melbourne. Well done to our Coaches and Teams on this wonderful result and to Lacrosse Victoria and Lacrosse Western Australia on hosting these events.



Other activities throughout the year included -

The governance review and board restructure was an ongoing project during 2012, and is now at the stage where we will be trialling the new structure until the 2013 AGM. It is hoped that by reducing the size of the Board (to 7) its operations will be more streamlined, and by giving more responsibility to Committees to run their particular areas of operation, the Board will be able to concentrate more fully on governance and the more strategic issues facing our sport.

Camps for visiting Japanese teams in March, held in conjunction with Bunnik Travel and Trish Adams from Velocity Lacrosse.

Additional junior team compliancy requirement. In 2012 we included the need to have a minimum of five correct age players when nominating a team at the beginning of the year, and then to play in the finals. The intent of this was to prevent an Under 15 team (for example) being made up of mainly under 13 players playing two games in a day. Also, players were only permitted to play one age level above their playing age group e.g. an Under 13 player could play Under 15s, but not Under 18s.

Australian Club Championship. In a departure from the norm this event was hosted at a Club (Brighton Lacrosse Club) this year on the June long weekend. The change of venue caused some delay in arrangements, and only SA and Victorian teams participated, with Brighton winning both the Men's and Women's Championship. Thank you to Graham Hobbs and the Eureka Group for their generous and ongoing sponsorship of this event. The date for this event will have to be looked at next year, as it clashes with the ALA Men's and Women's Nationals in Melbourne.

The second division in the U13 Girls continued and a second division was introduced in the Under 15 Girls. These divisions are designed to encourage new girls to play our sport in an environment where they are able to compete and succeed while they are gaining the necessary skills to allow them to compete with more seasoned lacrosse players. Many of the teams are whole of College/School teams and there is increasing interest in the game generally from these schools which is very pleasing to see.

Box Lacrosse. The Adelaide Box Lacrosse Club was formed and affiliated with Lacrosse SA to manage that form of the game.

Channel 44. We branched into television with a 15 minute weekly program on Community TV Channel 44. Those who saw it and provided feedback seemed to appreciate it and enjoy it, but it is time consuming to produce. We will continue with our contract pre and early 2013 season after which its resource to value ratio must be carefully assessed.

Grants. As well as the grant to provide Coaches and Officials training, we received a 3 year (notional for 3 years, subject to performance) allocation of \$40,000 per year to provide "Leadership, Policies and Services". We also secured a \$5,000 grant for a project "Keeping Young Women in Sport". This grant – largely for research, is being managed by the Development Committee. This is great support from the Government of SA through the Office for Recreation and Sport.

Spectator Facility at Finsbury Reserve. A temporary facility was in place for this season, but we are pleased to advise that the construction of the permanent stand is about to start and should be ready for next season. This project is another very practical demonstration of Graham Hobb's support for our game - thank you once again Graham and the Eureka Group.

The Board has committed to a culture of increased transparency and consultation and are committed to the development of a new Strategic Plan.



Development

Lacrosse Victoria has embarked on a program to grow the sport through our schools, with a Teacher Resource training program being targeted at teachers in our local schools and trainee teachers at University, to be able to run their own Lacrosse programs, along with the support of local club members.

Regional development in Bendigo and Warrnambool has been welcomed by the regional communities in providing a new and unique sport for students to play, exposing these children to sports other than the traditional sports available to country communities. Teachers have embraced the sport, recognising the benefits of how a new sport can involve students who were otherwise disinterested in the traditional sports.

Although in its infancy, the introduction of a VicLax program at introductory level, based along the lines of the successful Auskick and Milo Cricket concepts of taking the grassroots level out to the community, appears to be growing support.

The by-line is for sports to continue in this competitive sector of community involvement, to become innovative or be swallowed up by the larger sports.

The Future of our Sport

Through years of experience, we realise that in Lacrosse we have the best product to develop a strong healthy population, team oriented participants in a family and community based sport, which is welcoming, accessible and inclusive to all members of our community. Our sport is not large enough to build barriers to success for others, we as clubs, Associations and State Associations need to work together to take this sport to the heights of success and recognition it deserves.

b. Revenue

Revenue is recognised when the Company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Revenue is recognised net of the amounts of goods and services tax (GST) payable to the Australian Taxation Office.

The Company's revenue includes grants received from the Australian Sports Commission and membership fees.

Grants received on the condition that specified services are delivered, or conditions are fulfilled, are considered reciprocal. Such grants are initially recognised as a liability and revenue is recognised as services are performed or conditions fulfilled. Revenue from non-reciprocal grants is recognised when received.

Membership fees are recognised upon the delivery of the service to the members.

Donations and sponsorships are recognised when received.

Interest revenue is recognised on an effective rate basis taking into account the interest rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST).

c. Income Tax

The entity has received an endorsement from the ATO confirming that it is exempt from income tax.

d. Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the balance sheet.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST components of investing and financing activities, which are disclosed as operating cash flows.

e. Payables

Accounts payable are recognised when the entity becomes obliged to make future payments resulting from the purchase of goods and services.

f. New standards and interpretations not yet adopted

In the year ended 30 June 2012, the Company has reviewed all of the new and revised Standards and Interpretations issued by the AASB that are relevant to its operations and effective for the current annual reporting period.
